ORDINANCE NO. 5833

AN ORDINANCE OF THE CITY OF KLAMATH FALLS, OREGON, VACATING A PUBLIC UTILITY EASEMENT WITHIN THE FIRST ADDITION TO THE LOMA LINDA HEIGHTS SUBDIVISION.

WHEREAS, the Planning Commission did recommend the vacation of public utility easement hereinafter described and the City Council did concur with such recommendation; and, WHEREAS, said Planning Commission and City Council aid determine that such easement is not of public necessity and does in fact restrict development of adjacent property; and, WHEREAS, Pacific Power and Light Company, California Pacific Utility Company, Oregon Water Corporation, and Pacific Northwest Bell, consented to such vacation and did in fact recommend vacation of said hereinafter described

easement.

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Klamath Falls as follows:

That particular public utility easement, 16 feet in width, (occupying the easterly 8 feet of lot 9 and westerly 8 feet of lot 8), and parallel to the interior lot line of Lots 8 and 9, of Block 2, of the First Addition to the Loma Linda Heights Subdivision is hereby vacated.

Be it further ordained by said Council, that a copy of this ordinance shall be filed with the County Clerk.
