QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, That Sperry Rand Corporation, New Holland Division

forever quitclaim unto the STATE OF OREGON, by and through its STATE HIGHWAY COMMISSION,
hereinafter called "Grantee", the following described property, to wit:

PARCEL 1

A parcel of land lying in the SE's of Section 1, Township 39 South, Range 9 East, W.M., Klamath County, Oregon and being a portion of that property described in that deed to Leon R. Andrieu and Minnie R. Andrieu, recorded in Book 355, Page 236 of Klamath County Record of Deeds; the said parcel being that portion of said property included in a strip of land 44 feet in width, lying on the Southwesterly side of the center line of the Klamath Falls - Lakeview Highway as said highway has been relocated, which center line is described as follows:

Beginning at Engineer's center line Station 160+00, said station being 1251.29 feet North and 2642.69 feet West of the Southeast corner of Section 1, Township 39 South, Range 9 East, W.M.; thence South 46° 06' 30" East 3050 feet to Engineer's center line Station 190+50.

Andrieu, recorded in Book 355, Page 236 of Klamath County Record of Deeds; the said parcel being that portion of said property lying Southwesterly of Parcel 1 and included in a strip of land variable in width, lying on the Southwesterly side of the center line of the Klamath Falls in width, lying on the Southwesterly side of the center line is Lakeview Highway as said highway has been relocated, which center line is described in Parcel 1.
