QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, That KLAMATH COUNTY, a governmental subdivision of the State of Oregon, herein-after called the Grantor, for the consideration hereinafter stated, to Grantor paid by GLENN C. MILLER, sole heir of the Estate of NORMA G. MILLER, hereinafter called the Grantee, does hereby release and forever quitclaim unto the said GLENN C. MILLER and unto his heirs and assigns, all right, title and interest of Grantor in and to the following described parcel of real estate, together with the tenements, hereditaments and appurtenances, situate in the County of Klamath, State of Oregon, to-wit:

That portion dedicated by the subdividers and designated as "Park" in MILLER PARK, a resubdivision situate in the NW-1/4 NE-1/4 Section 3, Township 39 South, Range 9 EAST, W.M., Klamath County, Oregon;

TO HAVE AND TO HOLD The same to the said GLENN C. MILLER and to his heirs and assigns forever.

This deed is executed to correct the deed dated July 6, 1970, and recorded in Volume M-70, page 5547.

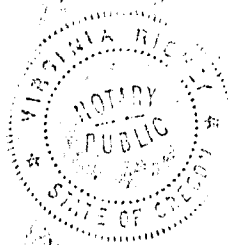
