EASEMENT AND RIGHT OF WAY.

KNOW ALL MEN BY THESE PRESENTS, That SHADOW HILLS, INC., an Oregon Corporation, hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto ENTERPRISE IRRIGATION DISTRICT of the State of Oregon, hereinafter called grantee, and unto grantee's successors and assigns, an easement and right of way situated in the County of Klamath, State of Oregon, described as follows, to-wit:

A 17 foot easement for irrigation supply line, more particularly described as follows:

A strip of land being the Southerly 17 feet of Tracts 6, 11, 12 and 15, Enterprise Tracts, lying Westerly of the existing main Enterprise Irrigation District canal in said Tract 6 and easterly of the existing Enterprise Irrigation District lateral in said Tract 15, being situated in Sections 34 and 35, T 38 S., R. 9 E., W.M., Klamath County, Oregon.

Together with the right of ingress and egress in, on, over, upon and across said Tracts 6, 11, 12 and 15 for the purpose of maintaining said supply line.

TO HAVE AND TO HOLD The same unto said grantee and grantee's successors and assigns forever.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 0.
