

THIS AGREEMENT made this 12<sup>th</sup> day of November, 1971, by and between  
GLADYS WALLAND TERRY, First Party and VANGELINE A. REED, Second Party,

## WITNESSETH:

WHEREAS the First Party owns an easement for roadway purposes across the  
land owned by the Second Party; and

WHEREAS both parties wish to extinguish a portion of the present easement  
and create a new easement across the Second Party's property.

NOW THEREFORE in consideration of those premises and the agreement here-  
inafter contained it is hereby agreed as follows:

The First Party does hereby remise, release and quitclaim unto the Second  
Party, her heirs, successors and assigns all of the First Party's right, title  
and interest in that portion of the easement owned by the First Party, on real  
property in Klamath County, Oregon described as follows:

The West 12 feet of E $\frac{1}{2}$  of the W $\frac{1}{2}$  of the S $\frac{1}{2}$  of the NE $\frac{1}{4}$  of the NE $\frac{1}{4}$   
of Section 23, Twp. 35 South Range 6 E.W.M., Excepting therefrom  
the North 358 feet, and excepting therefrom the South 12 feet.

The Second Party does grant, assign and convey to the First Party her  
heirs, successors and assigns an easement for road purposes across the follow-  
ing described real property in Klamath County, Oregon:

The West 12 feet and the South 12 feet of the W $\frac{1}{2}$  of the W $\frac{1}{2}$  of the S $\frac{1}{2}$   
of the NW $\frac{1}{4}$  of the NE $\frac{1}{4}$  of Section 23 Twp. 35 South Range 6 E.W.M.,  
Excepting therefrom the North 358 feet.

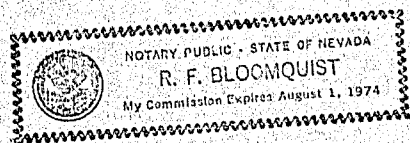
