WARRANTY DEED TO CREATE ESTATE BY THE ENTIRETY This Indenture Mitnesseth, THAT SUE McDONALD, who took title as Sue Jewell,

bargained and sold, and by these presents do es grant, bargain, sell and convey unto hos JOHN C. SIEMENS and RUTH E. SIEMENS, husband and wile, grantees, the following described premises, situated in Klamath County, Oregon, to-wit:

A portion of the SEXSWX of Section 31, Township 34 South, Range 7, E.W.M., described as follows:

Beginning at an iron pin located West 731.37 feet and North 0°13' East 462.84 feet from the South 1/4 corner of said Section 31. said point situated on the Easterly right of way line of State Highway No. 427; thence at right angles to said highway South 89°47' East 217.80 feet to an iron pin; thence North 0°13' East parallel with said highway 100.00 feet to an iron pin; thence North 89°47' West 217.80 feet to an iron pin on the Easterly right of way line of said highway; thence South 0°13' West along said right of way line 100.00 feet, more or less, to the point of beginning.

Subject to: Any existing easements visible on the ground for roads, pipelines or utilities, to which the property might be subject under provisions of Land Status Report recorded in Deed Volume 307 at page 529; rights of the public in and to any portion of said premises lying within the limits of roads and highways.
