THIS INDENTURE, made this 11th day of February, 1972, between the UNITED STATES OF AMERICA, acting herein by and through the Associate Deputy Chief, Forest Service, Department of Agriculture, hereunto duly authorized by the Act of March 3, 1925 (43 Stat. 1215), the delegation of authority and assignment of functions by the Secretary of Agriculture dated November 27, 1964 (29 Fed. Reg. 16210), the delegations of authority effective October 20, 1971, by the Acting Secretary of Agriculture and the Assistant Secretary for Rural Development and Conservation (36 Fed. Reg. 21529), and the delegation of authority by the Chief, Forest Service, dated June 5, 1968 (33 Fed. Reg. 8552), the provisions of which have been complied with, Grantor, and WILLARD K. PLUMMER and NORINE PLUMMER, Grantees:

WITNESSETH: That the Grantor, for and in consideration of the conveyance to it by the Grantees of land in Klamath County, Oregon, more particularly described in the deed to the United States executed November 2, 1971, and recorded on November 3, 1971, in Volume M-71 of Deeds on page 11514, Official Records of Klamath County, Oregon, which is of at least equal value to the land herein conveyed, the receipt of which is hereby acknowledged, does hereby remise, release and quitclaim to the Grantees all interest in the following described real estate situated in the County of Klamath, State of Oregon:

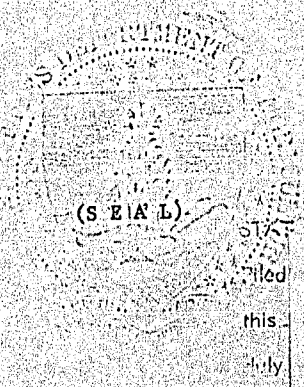

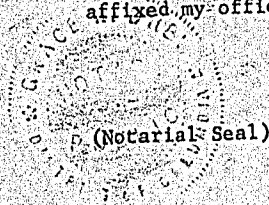
