PARTIAL RELEASE OF MORTGAGE

 thence North 17° 15' West 132.0 feet;  
 thence North 18° 00' West 264.0 feet;  
 thence North 19° 00' West 132.0 feet;  
 thence North 21° 00' West 132.0 feet to a point,  
 said point being North 1393.8 feet and West 835.0 feet from said section corner,

and that the remainder of said lands and said mortgage specified shall remain thereto as heretofore.

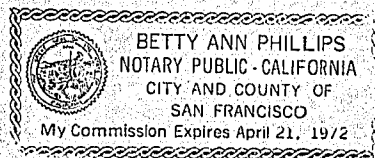
