GRANT OF EASEMENT

THIS INDENTURE, WITNESSETH That GEORGE F. CRAIN and DOROTHY LUCILLE CRAIN, husband and wife; CHARLES A. FISHER and MARY LOU FISHER, husband and wife, and CHAUNCEY A. FISHER and FLORENCE M. FISHER, husband and wife, herein called "grantors", in consideration of the sum of TEN AND NO/100 DOLLARS to them paid, have bargained and sold and by these presents to grant, bargain and sell to FIRST CHURCH OF THE NAZARENE, herein called "grantee", a perpetual right and easement over, upon and across a parcel of land 60 feet in width, being parallel with and 30 feet on each side measured at right angles, from the followingdescribed centerline, situated in the SELNW, Section 1, Township 39 S., R. 9 E.W.M., Klamath County, Oregon, to-wit:

Beginning at a point S. 88°53'17" W. 150.26 feet from the Northeast corner of the SEINW: of said Section 1, said point being on the South line of the Third Addition to Winema Gardens in the center of Chinchalla Way; thence S. 00°05'00" E., along the centerline of said Chinchalla Way extended, a distance of 160.00 feet, more or less, to the North line of that tract of land described in Deed Volume M-69, Page 8138, as recorded in the Klamath County Deed Records, with bearings based on the said Third Addition to Winema Gardens.

ALSO a perpetual right and easement over, upon and across a parcel of land 60 feet in width, being parallel with and 30 feet on each side measured at right angles, from the following-described centerline, situated in the SWHNEL, Section 1, Township 39 S., R. 9 E.W.M., Klamath County, Oregon, to-wit:

Beginning at a point S. 00°47'38" E. 460.12 feet from the Northwest corner of the SW1NE2 of said Section 1, said point being on the north-south centerline of said Section 1 and the West line of that tract of land described in Deed Volume M-69, Page 8138, as recorded in the Klamath County Deed Records; thence N. 89°12'22" E. 140.00 feet; thence N. 00°47'38" W. 140.00 feet, more or less, to the South end of Carlson Drive as platted in the First Addition to Moyina Manor, with bearings based on the Third Addition to Winema Gardens.

Said easements are granted for the purposes of permitting grantee, its invitees and the public access to and exit from adjacent lands now owned by grantee.
