CERTIFICATE OF WATER RIGHT

This Is to Certify, That KLAMATH FALLS FOREST ESTATES, UNIT 11

of 1801 Century Park West, Los Angeles, State of California, has made proof
to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of
Wild Horse Spring Area and reservoir constructed under application number R-41263,
— permit number R-4642 for the purpose of
a tributary of Wild Horse Canyon
landscaping

under Permit No. 30749 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from June 1, 1965

that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.
The point of diversion is located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 22, T. 37 S., R. 11 E., W. M.
Spring Area located: 2330 feet East and 1280 feet North from SW Corner, Sec-
tion 22.

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to ----- of one cubic foot per second
per acre,

and shall
conform to such reasonable rotation system as may be ordered by the proper state officer.
A description of the place of use under the right hereby confirmed, and to which such right is
appurtenant, is as follows:

Section 22
T. 37 S., R. 11 E., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
use herein described.
