WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That IVA BELLE CAMPBELL, hereinafter called the Grantor, for the consideration hereinafter stated, to Grantor paid by LAURENCE C. CAMPBELL and SANDRA L. CAMPBELL, husband and wife, hereinafter called the Grantees, does hereby grant, bargain, sell and convey unto the said Grantees and Grantees' heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lot 17 of PIEDMONT HEIGHTS and the N½ of vacated Jones Avenue adjoining the South line of said Lot 17, EXCEPTING from said Lot 17 a tract of land lying North of the Enterprise Irrigation ditch in Lot 17, PIEDMONT HEIGHTS, an addition in Klamath County, Oregon, situated in the E½SE½ Section 1, Township 39 South, Range 9 East of the Willamette Meridian, and more particularly described as follows:
