SUBORDINATION OF MORTGAGE TO ACCESS RESTRICTIONS

"There is reserved unto Grantors, their heirs and assigns, for service of the above described property, access rights from said property to the highway right of way at the following place and for the following width:

"If, after written notice to desist, Grantors, or any person holding under them, shall use the above place of access in a width greater than above stated, or shall permit or suffer any person to do so, the right of access therefor shall automatically be suspended and State shall thereupon have the right to close said place of access. The suspension shall terminate when satisfactory assurance has been furnished State that the place of access will be used in a width not greater than above stated.

AND DOES ALSO HEREBY FURTHER SUBORDINATE the remainder of the property covered by the lien of said mortgage to that certain easement for irrigation facilities contained in those documents mentioned above to the State of Oregon, by and through its State Highway Commission, over, across and upon the following described property, to wit:
