1 KNOW ALL MEN BY THESE PRESENTS, that First Federal Savings and Loan Associa-

 4 does by these presents re-assign and transfer to said Assignees all of the  
 5 Assignor's right, title and interest, which is an undivided 1/3 interest, in and  
 6 to that certain Agreement of Sale dated June 12, 1964, wherein Marie G. Ragland  
 7 and Ross Ragland her husband; Carolyn Collier Larson (formerly Carolyn Collier)  
 8 and Thomas J. Larson, her husband; and Phyllis G. Kerns (formerly Phyllis G.  
 9 Igl) and Robert Benjamin Kerns, her husband, agreed to sell and Roy T. Lindley  
 10 and Patricia E. Lindley, husband and wife, agreed to buy the following described  
 11 parcel of real property situate in Klamath County, Oregon, to-wit:

12 Lots 7 and 8, Block 13 of ORIGINAL TOWN OF LINKVILLE, now City of Klamath  
 13 Falls, Oregon, SAVING AND EXCEPTING a strip or parcel 8 feet in  
 14 width off the Southeasterly ends of said lots, heretofore deeded to  
 the public for alley purposes;

15 which said contract was assigned by said Assignees to said Assignor as security  
 16 for the payment of that certain Note dated April 11, 1967, made and executed by  
 17 said Marie G. Ragland and Ross Ragland to said First Federal Savings and Loan  
 18 Association of Klamath Falls, a Federal Corporation, as payee; provided, however,  
 19 that it is understood and agreed that this re-assignment is intended solely to  
 20 release said agreement as security for said note, and said note has been fully  
 21 paid.

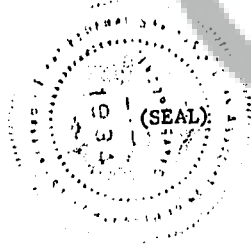
22 TO HAVE AND TO HOLD the same unto the Assignees, their heirs and assigns

10 voluntary act and deed.

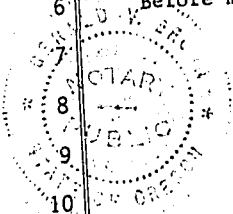
