

PARTIAL RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, That the undersigned trustee, or successor trustee, under that certain trust deed dated October 18, 1965, executed and delivered by Jimmie L. Hargrove and Sharon L.
