TRUST DEED

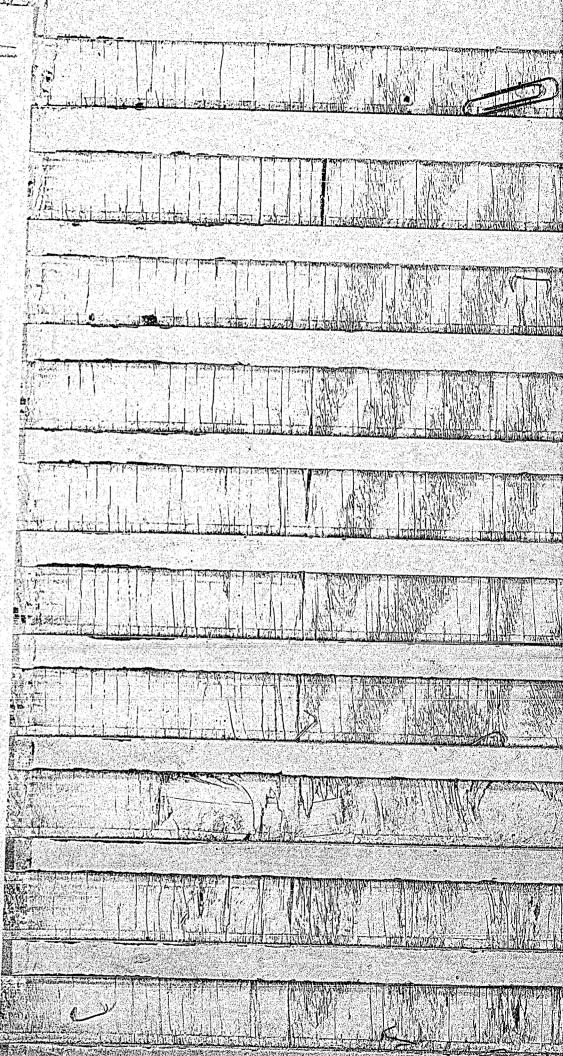
