MEMORANDUM OF AGREEMENT between GILCHRIST TIMBER COMPANY, hereinafter called Gilchrist, and BROOKS SCANLON, INC., hereinafter called Brooks.

Gilchrist and Shevlin-Hixon Company entered into an agreement on August 12, 1943, recorded in Volume 159, page 300, Deed Records of Klamath County, Oregon, concerning mutual rights between them for the use and maintenance of truck roads, railroads, skidroads, and telephone lines on property owned by each party, including Township 23, Range 9, EWM, Klamath County, Oregon.

Brooks is the successor in interest of Shevlin-Hixon Company.

In consideration of the release of mutual rights in the agreement of August 12, 1943, Brooks and Gilchrist hereby agree that they release any and all rights and claims for construction, use and maintenance of each other for truck roads, railroads, skidroads or telephone lines or other roads and lines in the Southwest Quarter of Section 13, Township 23, Range 9, EWM, Klamath County, Oregon.

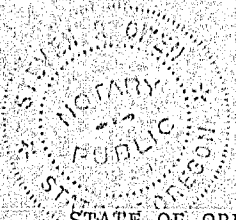

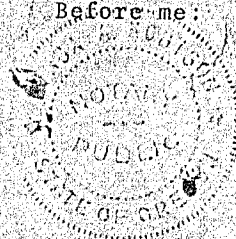
