way and South 0°57' East 100 feet from the Northeast corner of Govern-

25 feet; thence West to the Easterly near high water line of Agency  
Lake; thence Northerly along said high water line of Agency Lake a  
distance of 25 feet more or less to a point due West of the point of  
beginning; thence East to the point of beginning.
