REYNOLDS, husband and wife , hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit: A tract of land situated in Lot 2, Section 15, Township 34 South, Range 7 East of the Willamette Meridian, Klamath County, Oregon and being more particularly described as follows:

Beginning at the Northwest corner of Section 15, T. 34 S., R. 7 E., W.M. and running thence N. $39^{\circ}42'15''$ E. along the North line of said Section 15, 400.0 feet; thence South 62.42 feet; thence S. $50^{\circ}43'50''$ E. 453.16 feet; thence S. $76^{\circ}17'30''$ E. 39.11 feet to the true point of beginning of this description; thence S. $13^{\circ}42'30''$ E. 420.03 feet to a point on the North bank of the Williamson River; thence S. $80^{\circ}04'20''$ E. 110.24 feet; thence N. $13^{\circ}42'30''$ E. 412.76 feet; thence N. $76^{\circ}17'30''$ E. 110.0 feet to the true point of beginning of this description.

SUBJECT TO: Reservations and restrictions of record, easements and rights of way of record and those apparent on the land.

To Have and to Hold the above described and granted premises unto the said grantee and grantee's heirs, successors and assigns forever.

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except as hereinabove set forth

and that grantor will warrant and forever defend the above granted premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever.
