A portion of Tract 43, ENTERPRISE TRACTS, Klamath County, Oregon, more particularly described as follows:

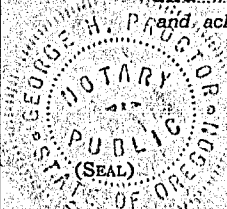
