WARRANTY DEED TO CREATE ESTATE BY THE ENTIRETY

This Indenture witnesseth, THAT GEORGE F. WILLIAMS and LOUISE M. WILLIAMS, husband and wife, hereinafter known as grantor s, for the consideration hereinafter stated have bargained and sold, and by these presents do grant, bargain, sell and convey unto WESLEY D. KELLOM and JULIE A. KELLOM,

husband and wife, grantees, the following described premises, situated in Klamath County, Oregon, to-wit:

A parcel of land situate in the N<sup>W</sup> S<sup>E</sup> SE<sup>1/4</sup> of Section 3, Township 39 South, Range 9 E.W.M., more particularly described as follows:

Beginning at a point which lies North 1°14' West a distance of 495.8 feet and South 89°26' West a distance of 730 feet from the iron pin which marks the Southeast corner of Section 3, Twp. 39 S. R. 9 E.W.M.; thence continuing South 89°26' West 100 feet to a point; thence North 1°14' West 144.5 feet to a point; thence North 89°26' East 100 feet to a point; thence South 1°14' East 144.5 feet to the point of beginning,

Subject to acreage and use limitations under provisions of the United States Statutes and Regulations issued thereunder; contract and/or lien for irrigation and/or drainage; easements and rights of way of record and those apparent on the land; rules, regulations, liens and assessments of South Suburban Sanitary District.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 2,750.00.

and that they will warrant and defend the same from all lawful claims whatsoever, except those above set forth.
