2 THIS DEED, made June 27, 1972, between J.M. BRITTON,  
3 Sheriff of Klamath County, Oregon, hereinafter called Grantor  
4 and MABEL C. MORGAN hereinafter called Grantee

5 W I T N E S S E T H:

6 WHEREAS, in a suit in the Circuit Court of the State of  
7 Oregon for Klamath County, Oregon, between MABEL C. MORGAN, Plain-  
8 tiff, and DALLAS G. GIVAN, SR., and PATRICIA ANN GIVAN, husband  
9 and wife, et al, Defendants, a judgment and decree was entered on  
10 April 19, 1971, for the foreclosure of a mortgage on the real  
11 property described below; and

12 WHEREAS, the Court thereafter issued a writ of execution and  
13 pursuant thereto on June 8, 1971, all of the interest of the  
14 Defendants in the real property was sold at public auction, sub-  
15 ject to redemption, in the manner provided by law, for the sum  
16 of \$56,939.78, to MABEL C. MORGAN, the highest bidder; and

17 WHEREAS, the Sheriff, after receiving from the purchaser  
18 the sum of money so bid, duly executed and delivered to the pur-  
19 chaser a Certificate of Sale; and

20 WHEREAS, the Sheriff then filed the return of sale with the  
21 Court and an Order confirming the sale was entered on July 15,  
22 1971; and

23 WHEREAS, the time for redeeming as required by law has ex-  
24 pired, the real property has not been redeemed from the sale, and  
25 the Grantee herein is the owner and holder of the Certificate of  
26 Sale and has delivered the Certificate to Grantor.

27 NOW, THEREFORE, in consideration of the sum paid for the real  
28 property Grantor does hereby convey to Grantee all of the interest  
29 the Defendants had on April 1, 1966, the date of the mortgage,  
30 and all interest which Defendants had thereafter in that real  
31 property described as follows:
