in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any-
wise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Lots 9 and 12, S 1/2 of Lot 2, and that portion of Lots 8, 13 and 18
described as follows: Beginning at a point where the south boundary of
Lot 18 intersects the west bank of Williamson River and running thence
West 4.30 chains; thence North 30 chains to a point of intersection with
the north boundary of Lot 8; thence East 10 Chains to the northeast corner
of said lot 8, thence South 12 chains to Williamson River; thence South
and West along the bank of Williamson River to the place of beginning,
containing 37.24 acres, more or less, and the North portion of Lot 2, which
is more particularly described as follows: Beginning at the corner to
fractional Sections 19 and 30, on the right bank of Williamson River;
