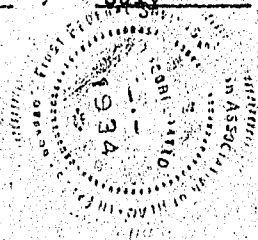


## SATISFACTION OF MORTGAGE

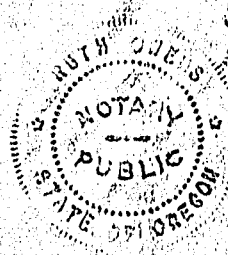
