

RELEASE OF JUDGMENT LIEN

South 57° 30' East a distance of 1350 feet; thence  
North 37° 30' East a distance of 880 feet, more or  
less to a point that is 307 feet Westerly from measured

Westerly from the North-South centerline of said Sec-  
tion to a point that is 40 feet Southerly from measured  
at right angles to the East-West centerline of said

Northeasterly to a point on the Southerly right of way  
line of the Sprague River Highway, to a point that is  
200 feet Southeasterly along the South right of way  
line of the Sprague River Highway from the intersection  
of the North-South and the South right of way line of  
the Sprague River Highway; thence Southerly following  
the Southerly right of way line of said Sprague River  
Highway to the South line of said Section 3; thence  
West on said South line to the point of beginning,

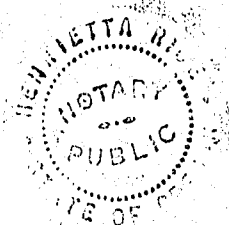
