SHERIFF'S DEED

WITNESSETH:

WHEREAS, in a suit in the Circuit Court of the State of Oregon for Klamnth County, Oregon, between Lloyd Gift, individually, and Lloyd Gift, Executor of the Estate of Bobbiette Gift, deceased, Plaintiffs, and Norman D. Jacob, also knwon as Norman Dale Jacob; Fred Burgoyne, Burgoyne & Thompson, a copartnership consisting of Fred Burgoyne and Roger Thompson; and United States

National Bank of Oregon, a national banking association, defendants, a judgment and decree was entered on June 10, 1971, for the foreclosure of a mortgage on the real property described below; and

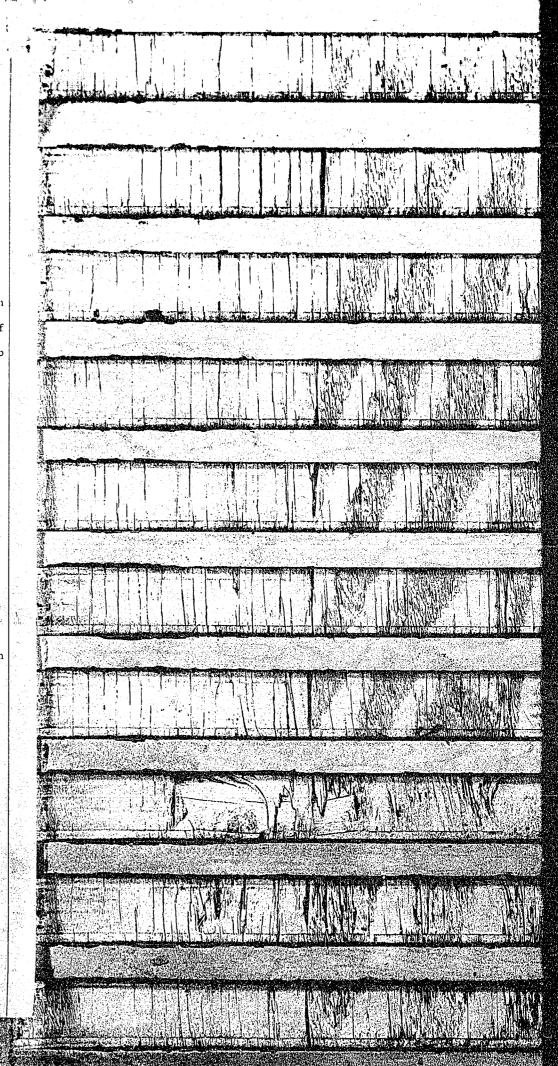
WHEREAS, the Sheriff then filed the Return of Sale with the Court and an Order Confirming the Sale was entered on August 2 , 1971; and
