

Such installments shall be equal respectively to one-twelfth (1/2) of the annual ground rent, if any, plus the estimated premium or premiums for such insurance, and taxes and assessments next due (as estimated by Beneficiary, and of which Grantor is notified) less all installments already paid therefor, divided by the number of months that are to elapse before one month prior to the date when such premium or premiums and taxes and assessments will become delinquent. Beneficiary shall hold such monthly paynents in trust to pay such ground rents, premium or premiums, and taxes and special assessments before the same become delinquent.




