KNOW ALL MEN BY THESE PRESENTS, That HAZEL HINTZ, Formerly Hazel Short;

being all of the heirs and/or devisees of Clementine Short, deceased, do hereby relinquish and forever quitclaim unto H. N. RING, the following described property, to wit:

That property situated in the County of Klamath, State of Oregon, beginning at a point 989.8 feet East of the Northwest corner of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 1, Township 39 South, Range 9 East, W.M. on the north boundary of said NE $\frac{1}{4}$ of SW $\frac{1}{4}$; thence South at right angles 936.8 feet, more or less, to the north boundary of the State Highway; thence southeasterly along said line of Highway to intersection with a line running north and south and parallel to the first course and distance 110.5 feet east of the first course; thence north along said line 1041.7 feet; thence west along the north line of said NE $\frac{1}{4}$ of SW $\frac{1}{4}$ 110.5 feet to the point of beginning, containing 2 $\frac{1}{2}$ acres, more or less.

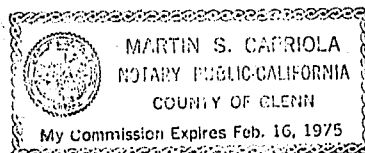
