STELSON-NESS LAW PUB. CO., PORTLAND, ORE.

CHAPTER 486, OREGON LAWS 1965, repeals ORS 23.180 and enacts the following Section 2 in lieu thereof:

"Section 2. (1) The earnings of any debtor for personal services performed by him shall be exempt from garnishment, or any other legal process, as follows:

(a) Except as provided in paragraph (c) of this subsection, any earnings for personal services performed by a debtor and owing to him at the time of service of any garnishment, or any other legal process, shall automatically be exempt from the effect of such process to the extent of 50 percent of the amount thereof or \$25, whichever is larger, up to a maximum exemption of \$250 in any 30-day period.

(b) Any amount so exempted shall remain exempt from further legal process until paid to the debtor.

(c) No earnings of any debtor shall be exempt from any legal process issued to collect income tax owed to the state by such debtor or issued to enforce a judgment for damages for fraud.

(2) Every contract entered into by a debtor, the purpose or effect of which is to waive the right of exemption granted by this section, is void.

(3) "Earnings" as used in this section means that money owing after deducting state and federal taxes as required by law.

(4) A copy of this section shall be attached to or made a part of any legal process served on a garnishee."
