PARTY WALL AGREEMENT

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars and other 21 good and valuable considerations to First Party in hand paid, the receipt of 22 which is hereby acknowledged, First Party, his heirs, executors, grantees and 23 assigns, does hereby grant to and covenant with Second Party, his heirs, exc-24 cutors, administrators, grantees and assigns, that he and they may use the 25 Westerly wall of First Party's building aforesaid as a party wall, with all 26 the rights and incident thereto; provided, however, that Second Party will not 27 28 insert ceiling beams and floor joists into the said party wall, it being expressly understood, by and between the parties hereto, that Second Party will 29 erect support timbers adjacent to the party wall and affix same with bolts to 30 the party wall, then run a stringer across the erected timbers for their 31 32 ceiling beams.

9289 1 It is further covenanted and agreed by the parties hereto, for themselves 2 and their respective heirs, executors, administrators and assigns, that should 3 the party wall at any time while in use by both parties as aforesaid be injured 4 by other cause than the act or negligence of either party, the same shall be re-5 paired or rebuilt at their joint expense provided that any sum received from 6 insurance against such injury or destruction shall be first applied to such res 7 toration, and that whenever the wall or any part of it shall be rebuilt, it 8 shall be erected on the same spot where it now stands and be of the same size 9 and of the same or similar materials; and that said party wall shall be main-10 tained and kept in repair at the joint cost of the respective adjoining owners. 11 It is further agreed and understood by the parties hereto for themselves 12 and their respective heirs, executors, administrators and assigns that this in-13 strument shall be perpetual and that the covenants herein contained shall run 14 with both parcels of land above described, but it shall not have the effect to 15 convey to either party the fee to any part of the land owned or to be acquired 16 by the other party, the creation of the right to a perpetual party wall being 17 the sole purpose hereof. 18 The covenants aforesaid are to run with the land and to bind the parties 19 hereto, their heirs and assigns.
