1 THIS AGREEMENT made the day and year hereafter written between HAROLD
2 DEHLINGER & SON, a Partnership, herein called Dehlinger, and KLAMATH IRRIGATION
3 DISTRICT, an Irrigation District of the State of Oregon, herein called District.

WITNESSETH:

5 Dehlinger some years prior hereto granted to the District a right of
6 way for road purposes across Dehlingers lands along the F-1 Canal and the
7 F-1-a Lateral and the District constructed said Road and has used it without
8 interruption but since said Grant of Right Away was not reduced to writing
9 and the Parties now wish to make a permanent record of said Grant so the
10 same shall be definite and certain,

11 NOW THEREFORE, In consideration of the premises and of One Dollar paid
12 by the District to Dehlinger, Receipt of which is hereby acknowledged,
13 Dehlinger does hereby give, grant, confirm and convey to the District the
14 perpetual and irrevocable right of way for road purposes over and across
15 the following described premises, to wit:

16 A 10 foot strip of land beginning on the North side of the F-1 Canal in
17 the SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 28, Township 39 S, Range 10, E.W.M., Klamath County
18 Oregon, 310 feet more or less, West of the East Section line of said
19 forty; running thence North on the West side, parallel and adjacent to the
20 F-1-a lateral, existing and apparent on the land in said section, to inter-
21 sect with the South side of the East-West Crystal Springs Road, a County
22 Road a distance of 4,770 feet, more or less

23 to provide the District with access to and ingress and egress from said F-1
24 Canal and F-1-a Lateral for the purpose of operation, regulation, maintenance,
25 replacement, clearing and repair of said Irrigation System and all parts and
26 appurtenances thereto and to enable the District to patrol said Irrigation
27 System and to distribute water therefrom.

28 TO HAVE AND TO HOLD the same to Klamath Irrigation District, its successors,
29 grantees and assigns forever.

30 IN WITNESS WHEREOF the parties have caused this Agreement to be executed
31 this 4th day of August, 1972.
