

ORDINANCE NO. 5875

AN ORDINANCE INCORPORATING NEWLY ANNEXED PROPERTY INTO
WARDS AND CHANGING THE BOUNDARIES OF CERTAIN WARDS.

WHEREAS, the U.S. Supreme Court ruled on April 1, 1968, that a
resident of a local government has a right to a vote for the governing body
of substantially equal weight to the vote of every other resident; and

WHEREAS, in accordance with this ruling, certain Wards in the
City of Klamath Falls have been revised in order that each Ward have a more
equitable representation; and

WHEREAS, certain property has been annexed into the City of
Klamath Falls; therefore,

THE CITY OF KLAMATH FALLS ORDAINS AS FOLLOWS:

Section 1.

The Boundaries of the Wards of the City of Klamath Falls shall be
reapportioned as follows:

WARD I. Precinct Numbers 1,2,3,4,5,6,8,9,10, and 12

WARD II. Precinct Numbers 11,13,19,20,21,22,23,27, and 28

WARD III. Precinct Numbers 14,15,16,17, and 18

WARD IV. Precinct Numbers 24,25,26,34, and 35

WARD V. Precinct Numbers 7,29,30,31,32, and 33

as presently defined and shown on the maps of said City.

Section 2.

That the City Recorder and City Engineer of said City are hereby
directed to make said changes of record on the maps of said City. That the
City Recorder furnish the County Clerk of Klamath County, Oregon, a certi-
fied copy of this ordinance so she may change the maps in her office in accord
with this ordinance.

Section 3.

Time being of the essence, an emergency is declared to exist and this ordinance shall be in full force and effect from and after its passage by a three-fourths aye or nay vote of the Council and its approval by the Mayor.
