WARRANTY DEED TO CREATE ESTATE BY THE ENTIRETY

This Indenture Witnesseth, THAT JULIA PORRAS,

of Lot 2, the Southerly 85.82 feet of Lot 3, All in Block 14,  
INDUSTRIAL ADDITION TO THE CITY OF KLAMATH FALLS, Klamath  
County, Oregon, being all of said lots EXCEPT Northerly 46  
feet thereof.

Subject to: Taxes for fiscal year commencing July 1, 1972,  
which are now a lien but not yet payable; Easements and  
rights of way of record and those apparent on the land, if  
any.
