15 Hazel V. Fretwell, as executrix of the will of Anna G. Regnart,
16 also known as Anna M. Regnart, deceased, having heretofore filed her first
17 and final account and report and petition for its settlement and for final
18 distribution, and the account and report and petition having come on regularly
19 for hearing the 24th day of August, 1972, and a clerical error having been
20 made in the judgment as presented to the Court on that date, and on motion
21 of the petitioner herein for an amendment of said judgment to conform to
22 the order of the Court, the Court finds:

23 Due notice of the hearing of the petition has been regularly given
24 as required by law.

25 All the allegations of the petition are true.

26 Anna G. Regnart, also known as Anna M. Regnart, died testate
27 on July 8, 1971, in the County of Santa Clara, State of California, being at
28 the time of her death a resident thereof.

29 On July 29, 1971, Hazel V. Fretwell was appointed executrix
30 of the decedent's will. She qualified as executrix of the decedent's will
31 on that date and ever since has been and now is the executrix of the
32 decedent's will.

Notice to creditors has been duly given as required by law, the time for filing or presenting claims has expired, and the estate now is in a condition to be closed.

All claims filed or presented against the estate have been allowed by the executrix, and approved by this Court and paid.

All debts of the decedent and of the estate and all expenses of administration thereof except extraordinary fees and closing expenses have been paid.

9 A written report of the inheritance tax appraiser appointed herein
10 is on file, and an order fixing the inheritance tax due the State of California
11 from this estate has been made by this Court. The tax has been paid in full
12 as evidenced by the receipt of the County Treasurer of the County of Santa
13 Clara on file herein.

14 All personal property taxes due and payable by this estate have
15 been paid.

16 A federal estate tax return has been filed for this estate and the
17 tax shown to be due has been paid. The return has been audited and a
18 closing letter issued. The executrix paid federal estate taxes in the amount
19 of \$14, 949.43, which should be prorated and apportioned as provided by law,
20 and the prorated amounts should be charged against the interests in this
21 estate of the persons against whom the charge is made, allowing a credit
22 to Eva Louise Wasson of \$500.00 contributed by her to the estate toward the
23 payment of such tax. The federal estate tax should be prorated and charged
24 as follows:

1 All California income taxes and federal income taxes due and
2 payable by the estate have been paid.

3 The estimated expenses of closing the estate are \$100.00 and the
4 executrix should be authorized to withhold that sum from distribution.

5 The payment of the sum of \$2,263.78 by the executrix to herself as
6 payment in full of her statutory commissions for her services rendered in
7 the administration of this estate and the payment of the sum of \$2,263.78 to
8 Thompson, Curtis, Lawson & Parrish, as payment in full of their statutory
9 fees for their services rendered in the administration of this estate should
10 be approved.

11 The executrix should be authorized to pay Thompson, Curtis,
12 Lawson & Parrish, her attorneys, for their extraordinary services rendered
13 in the administration of this estate the sum hereafter specified.

14 All the assets of the estate are the separate property of the
15 decedent.

16 Distribution should be ordered as prayed for.

17 NOW, THEREFORE, IT IS HEREBY ORDERED AND ADJUDGED

18 that:

19 1. The administration of the estate is brought to a close.

20 2. The first and final account, petition and report of the executrix
21 are settled, allowed, and approved as filed.

22 3. All the acts and transactions of the executrix relating to the
23 matters set forth in the account, petition and report are ratified, confirmed
24 and approved.

25 4. The executrix is authorized and directed to retain the sum of
26 \$100.00 from distribution at this time to defray closing expenses, and any
27 unexpended portion of reserve for closing expenses is hereby distributed as
28 follows:

29 To Margaret Anne Trevisan, one-eighteenth (1/18) thereof.

30 To William Herbert Long, one-eighteenth (1/18) thereof.

31 To Patricia Eileen Jones, one-eighteenth (1/18) thereof.

32 To Herbert W. Regnart, one-sixth (1/6) thereof.

1 To Hazel V. Fretwell, one-sixth (1/6) thereof.

2 To Donald Edward Regnart, one-sixth (1/6) thereof.

3 To Eva Louise Wasson, one-sixth (1/6) thereof.

4 To Alice Brown, one-sixth (1/6) thereof.

5. The payment of the sum of \$2,263.78 by the executrix to herself as payment in full of her statutory commissions for her services rendered in the administration of this estate, and the payment of the sum of \$2,263.78 to Thompson, Curtis, Lawson & Parrish, her attorneys, as payment in full of their statutory fees for their services rendered in the administration of this estate is approved.

6. The executrix is authorized and directed to pay to her attorneys, Thompson, Curtis, Lawson & Parrish, for their extraordinary services rendered in the administration of this estate, the sum of \$475.00.

7. Notice to creditors has been duly given as required by law.

8. The California inheritance taxes due and payable by the estate have been paid.

9. The executrix is authorized to deduct from the distributive shares of the persons hereafter named the sum set opposite their respective names for inheritance taxes paid by the executrix in their behalf, as follows:

21 residue of the estate, less, however, the sum of \$3,737.35, being her prorata
22 share of the federal estate tax paid by the executrix and adjudged payable by
23 the distributee.

24 TO DONALD EDWARD REGNART, son of decedent: One-sixth (1/6) of the
25 residue of the estate, less, however, the California inheritance tax thereon in
26 the sum of \$92.66 paid by the executrix in his behalf, and less the sum of
27 \$896.97, being his prorata share of the federal estate tax paid by the executrix
28 and adjudged payable by the distributee.

29 TO EVA LOUISE WASSON, daughter of decedent: One-sixth (1/6) of the
30 residue of the estate, less , however, the sum of \$4,283.81, being her prorata
31 share of the federal estate tax paid by the executrix and adjudged payable by


