of the deed records of Klamath County) being 12.5 feet in width on either side of
the following described centerline:

Beginning at a point on the easterly right-of-way boundary of State Highway No. 39,
as the same is presently located and constructed, from which the monument marking
the Northwest corner of Section 18, T.39 S., R.10 E., W.M. (as established by
Recorded Survey No. 1018) bears West 30.0 feet and North 118.0 feet distant; thence
N 34° 19' E 106.5 feet, more or less, to a point on the southerly right-of-way
boundary of the county road identified as "Keller Road" from which point the
monument marking the Northwest corner of said Section 18 bears North 30.0 feet and
West 90.1 feet, more or less, distant; together with the right of ingress and egress
