all rights, title and interest in and to the following described parcel of real estate, situate in
Klamath County of Oregon, to-wit:

A piece or parcel of land situate in the SW $\frac{1}{4}$ -SW $\frac{1}{4}$ of Section 7, T.39 S., R.10 E., W.M. (being a portion of that parcel conveyed on Page 511 of Volume 214 of the deed records of Klamath County) and being more particularly described as follows:

Beginning at the intersection of the northerly right-of-way line of the county road identified as "Keller Road" (said right-of-way line being 30.0 feet northerly from the centerline of said county road) and the apparent centerline of the Enterprise Irrigation District's Main Canal, as both county road and canal are presently located and constructed, from which point the monument marking the Southwest corner of Section 7, T.39 S., R.10 E., W.M. (as established by Recorded Survey No. 1018) bears South 30 feet and West 217.5 feet distant; thence N 45° 39' W along the centerline of said canal 80.0 feet to an angle point; thence N 23° 12' W along the centerline of said canal 20.0 feet to a point; thence S 66° 48' W 30.0 feet to a point; thence S 6° 39½' W 62.9 feet to a point on the northerly right-of-way line of Keller Road; thence East 100 feet, more or less, to the point of beginning; being subject to all rights-of-way and/or easements of record or apparent on the premises with particular reference being made to the right-of-way or easement of the Enterprise Irrigation District for its Main Canal.

TO HAVE AND TO HOLD, the same, together with all and singular the hereditaments and appurtenances thereunto belonging or in anywise appertaining to the said Enterprise Irrigation District

and to its Successors
heirs and assigns forever.

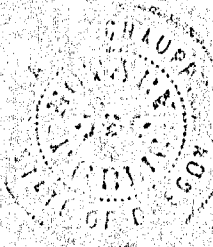
