A piece or parcel of land situate in the NE $\frac{1}{4}$ -NE $\frac{1}{4}$ of Section 13, T.39 S., R.9 E., W.M. (being a portion of that parcel conveyed on Page 578 of Volume 339 of the deed records of Klamath County) and being more particularly described as follows:

Beginning at a point at the intersection of the westerly right-of-way line of State Highway No. 39 and the apparent centerline of the Enterprise Irrigation District's Main Canal, as both highway and canal are presently located and constructed, and from which the monument marking the Northeast corner of Section 13, T.39 S., R.9 E., W.M. (as established by Recorded Survey No. 1018) bears East 30 feet and North 263 feet distant; thence N 89° 37' W along the centerline of said canal 70.0 feet to a point; thence N 0° 23' E 30.0 feet to a point; thence N 53° 02' 10" E 87.35 feet to the westerly right-of-way line of State Highway No. 39; thence South along said right-of-way line 83.0 feet, more or less, to the point of beginning; being subject to all rights-of-way and/or easements of record or apparent on the premises with particular reference being made to the right-of-way or easement of the Enterprise Irrigation District for its Main Canal.

(After deducting the area occupied by the canal, the above description includes approximately 0.06 Acres.)
