NOTICE OF
LIEN CLAIM

The Employment Division Administrator of Oregon hereby claims a lien in the amount of \$ 254.67 with interest on \$ 210.03 at the rate of one percent per month, or fraction thereof, until paid, upon:

Any and all of the real and personal property of whatsoever kind or nature, belonging to the defendant, lying or being situated in Klamath County, Oregon, and specifically described as follows:

Section 25: The E 1/2 SW 1/4 Excepting that portion used for State Highway purposes.

Section 35: The SE 1/4

Section 36: The NW 1/4; and the North 979 feet of the SW 1/4

All in Township 36 South, Range 11 East of the Willamette Meridian, in Klamath County, Oregon

Said lien is claimed for a sum equal to unpaid taxes due and payable for Second, Third and Fourth calendar quarters of 1971

and \$22.64 interest, with interest on \$ 210.03 in the amount of \$ 210.03 at the rate of one percent per month, or fraction thereof, from the 21st day of October, 1972, until paid, and penalty of \$ 21.00 (Penalties assessed under ORS 657.515)

That written demand for payment of the sum of \$210.03, then due, was made on the defendant on March 23, 1972, and defendant failed to make payment within ten days of said demand;

That because of the failure of defendant to make payment as required by the provisions of section 3 of ORS 657.515, defendant was in default;
