hereinafter called grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath, and State of Oregon, described as follows, to-wit:

Lot 12 less the Easterly 31.0 feet thereof of Burnsdales Subdivision of Klamath County, Oregon, according to the duly recorded plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Including the right to bring irrigation water over other lots in said subdivision but reserving the rights of way and easements for irrigation ditches and tile drains to carry irrigation and/or drainage for other lots in said subdivision and subject to contracts for irrigation and/or drainage, easements of record and those apparent on the land, and subject to the rules, regulations and assessments of the South Suburban Sanitary District within the boundaries of which district said property is located; and subject to the further restriction that not more than one single family dwelling containing not less than 1000 square feet of floor area shall be erected on said lot.

and that grantor will warrant and forever defend the above granted premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
