WARRANTY DEED TO CREATE ESTATE BY THE ENTIRETY

This Indenture Witnesseth, THAT LAWRENCE ALBERT SWETLAND and CLAIRE EMILE SWETLAND, husband and wife, hereinafter known as grantors, for the consideration hereinafter stated have bargained and sold, and by these presents do grant, bargain, sell and convey unto WILLIAM R. STEWART and MARY LOU STEWART, husband and wife, grantees, the following described premises, situated in Klamath County, Oregon, to-wit:

A portion of Block 41 of HILLSIDE ADDITION to the City of Klamath Falls, Oregon, according to the official plat thereof on file in the records of Klamath County, Oregon, more particularly described as follows:  
Beginning at a point on the Northwestern line of Portland Street which is 50.0 feet Northeastly from the Southwesterly corner of said Block 41; thence continuing Northeastly, along the Northwestern line of Portland Street, a distance of 120.0 feet to a point; thence Northwestly, parallel with the Southwesterly line of Hillside Avenue, a distance of 150.0 feet to a point; thence Southwestly, parallel with the Northwestern line of Portland Street, a distance of 120.0 feet to a point; thence Southeastly, parallel with the Southwesterly line of Hillside Avenue, a distance of 150.0 feet to the point of beginning.

Subject to: Easements and rights of way of record and those apparent on the land, if any.
