1 THIS IS THE LAST WILL AND WILL AND TESTAMENT of me, STEPHEN W. MOSS, of
2 Klamath County, Oregon.
3 FIRST: I revoke all other and former wills by me heretofore made.
4 SECOND: I nominate, constitute and appoint my wife, Mary E. Moss, to be executrix
5 of this will, to serve without bond. Should my said wife not survive me or be un-
6 able to act, I nominate, constitute and appoint Wm. Ganong to be such executor.
7 THIRD: I direct that my lawful debts and funeral expenses be paid as soon as
8 conveniently may be done after my decease.
9 FOURTH: I give and bequeath unto my granddaughter, Mary Anne Reynolds the sum
10 of \$10.00.
11 FIFTH: Should my said wife, Mary E. Moss, survive me, I give, devise and bequeath
12 all of the rest, residue and remainder of my property unto my said wife.
13 SIXTH: Should my said wife, Mary E. Moss, not survive me, I give, devise and
14 bequeath all of such rest, residue and remainder of my property as follows, to-wit:
15 (a) In case my wife's sister, Kathryn M. Carson, survives me, I give and
16 bequeath unto The First National Bank of Portland as Trustee, the sum of \$10,000
17 to be held by it, invested and reinvested and applied as follows, to-wit: Unto my
18 wife's sister, Kathryn M. Carson, the sum of \$100 per month for the term of her
19 natural life, and upon her death, said trustee shall pay and assign the remainder
20 of the trust estate unto The Imperial Council of Ancient Arabic Order of the
21 Nobles of the Mystic Shrine for North America, a corporation owning, operating and
22 conducting the "Shriners' Hospital for Crippled Children" to be used exclusively
23 for the benefit of the "Shriners' Hospital for Crippled Children" located in the
24 City of Portland, Oregon, absolutely.
25 (b) All of the rest, residue and remainder of my estate, including any lapsed
26 bequest or devise, unto The Imperial Council of Ancient Arabic Order of the
27 Nobles of the Mystic Shrine for North America, a corporation owning, operating and
28 conducting the "Shriners' Hospital for Crippled Children" to be used exclusively
29 for the benefit of the "Shriners' Hospital for Crippled Children" located in
30 the City of Portland, Oregon, absolutely.
31 SEVENTH: SAID executrix or executor, as the case may be, shall have the follow-
32 ing powers and authority in addition to those provided by law: To hold, manage,
care for and protect the estate and the income thereof; to operate and manage

1 any and all business belonging to my estate and any interest therein to the
2 extent of such interest, and to continue to operate the same; to sell, exchange,
3 partition, convey and lease the estate or any part thereof; to borrow money and
4 to pledge, mortgage or hypothecate all or any part of the estate as security there-
5 for; to lend her or his own funds to the estate for the protection thereof or
6 for any other purpose. Said executrix or executor may exercise any and all of
7 such powers or authority without regard to any prescribed statutory procedure,
8 and without petition, order, citation, license, authority or confirmation of any
9 court.
