INDENTURE OF ACCESS

WHEREAS, State by deed recorded September 11, 1952, in Book 256, at Page 559, Deed Records of Klamath County, Oregon, acquired from W. D. and Lottie M. Miller, husband and wife, certain property situated in Government Lot 3, Section 33, Township 38 South, Range 9 East, W.M., Klamath County, Oregon, which deed reserved for the service of the grantors' remaining property access rights to the Southerly side of the relocated Klamath Falls -Lakeview Highway opposite Engineer's Stations 48+50 and 50+35; and

WHEREAS, Owners by deed recorded in Volume M68, at Page 8265-67, Deed Records of Klamath County, acquired the fee title to that portion of said remaining property affected by the access changes herein made.

WHEREAS, Owners now have requested that said access rights opposite Engineer's Stations 48+50 and 50+35 be terminated and that there be substituted therefor access rights to the Southerly side of said highway opposite Engineer's Station 49+58; and

WHEREAS, State is agreeable to the granting of Owners' request.
