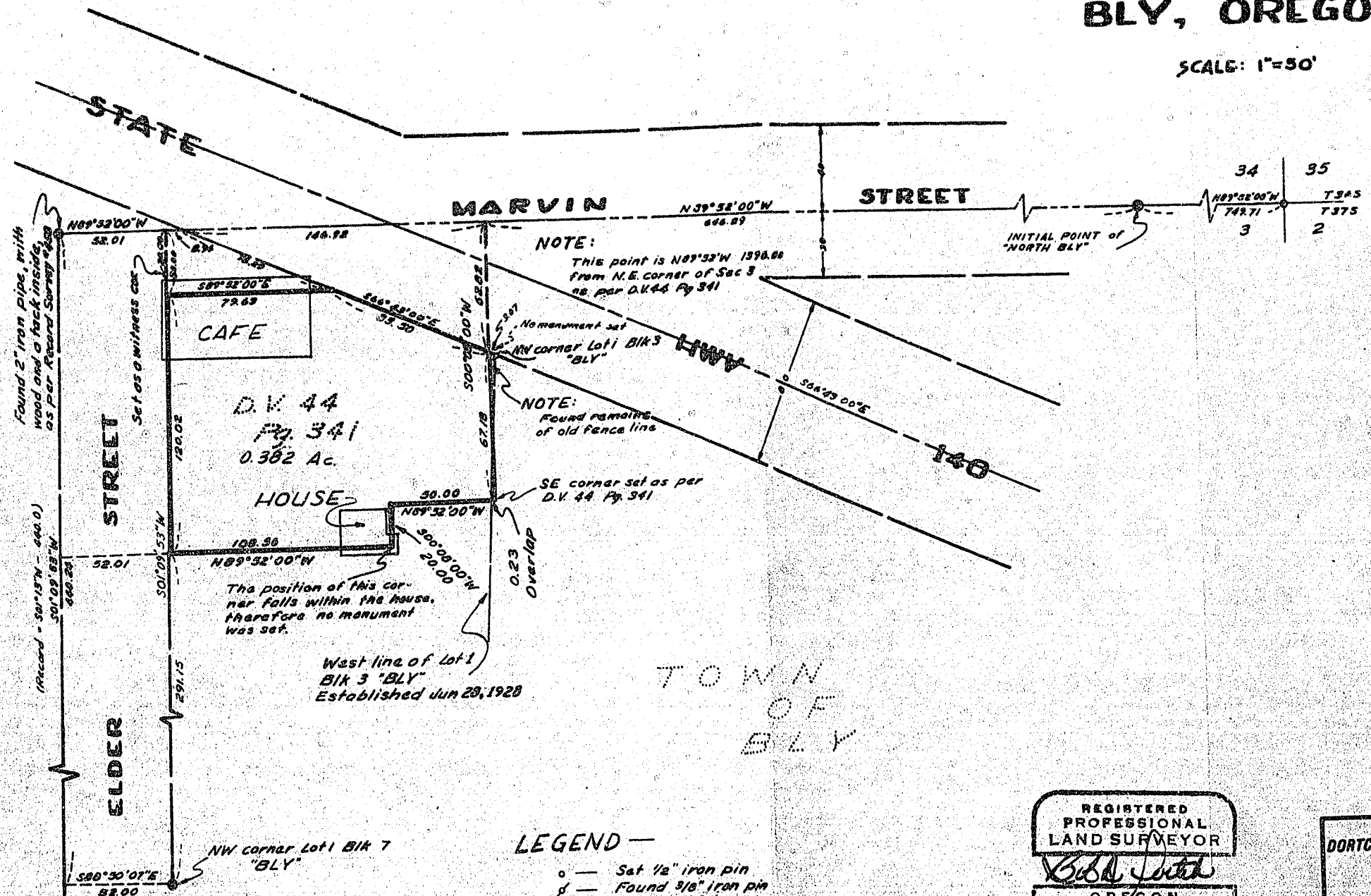

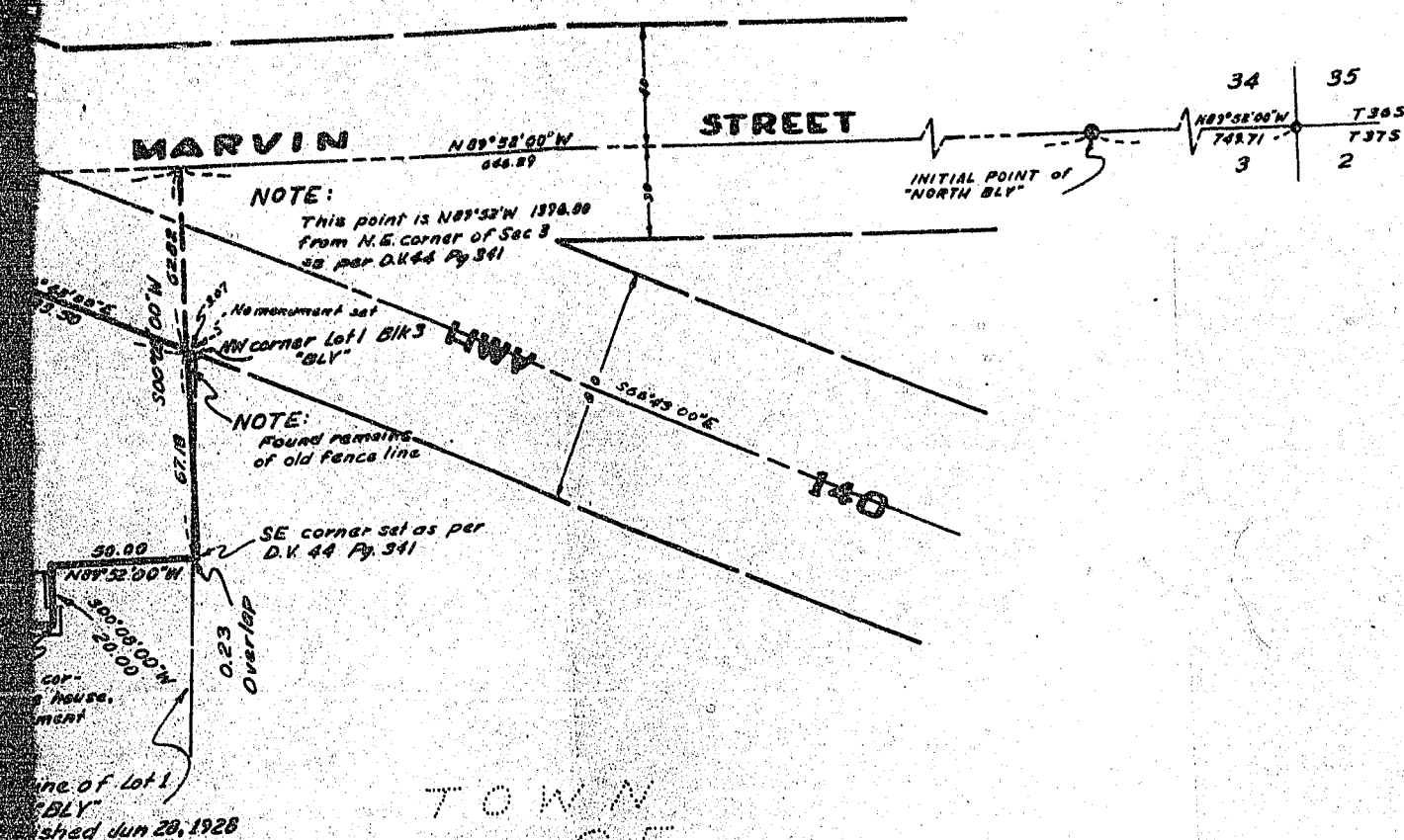

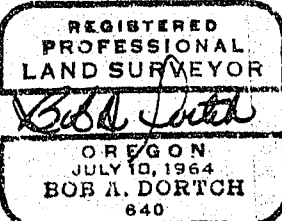
MAP OF SURVEY IN NORTH BLY SEC. 3, T37S, R14E, W.M. BLY, OREGON
