Range 7 East, W. M., more particularly described as follows, to-wit:

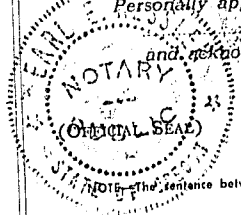
Beginning on the North line of the said SE 1/4 SE 1/4 at a point
