MANNING, of Klamath County, State of Oregon, has bargained and sold, and by these presents does grant, bargain, sell and convey unto said HOWARD J. MANNING, his heirs and assigns, all the following bounded and described real property situated in the County of Klamath and State of Oregon:

The SW-1/4 and NW-1/4 of Section 1, and NE-1/4 of Section 2, excepting therefrom 2.34 acres in the SW-1/4 of Section 1, deeded to Modoc Northern Railway Company, a Corporation, by deed recorded in Volume 30, page 479, Deed records of Klamath County, Oregon.

AND SE-1/4 of Section 2, less 5 acres forming a square in the SW corner of said SE-1/4, the same being reserved for a cemetery, all being situated in T. 40 S., R. 9 E., N. 2.

All subject to rights of way for canals and laterals and pole right of way to California Oregon Power Company, a Corporation of record.

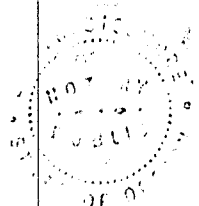
