LONDON, a widow, 8403 Blackburn Avenue, Los Angeles, California, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:
TOWNSHIP 36 South, Range 10 East, W.M.
Section 14: Government Lot #29, excepting therefrom a parcel of land to wit: beginning at a point 4620 ft. south and 30 ft. east of the Northwest corner of Section 14; thence South 40 ft.; thence East 243 ft.; thence North 40 ft.; thence West 243 ft. to the point of beginning, being a portion of Government Lot #29, Section 14, Township 36 South, Range 10 East, W.M.
