

and that the remainder of said lands and said mortgage specified shall remain thereto as heretofore.



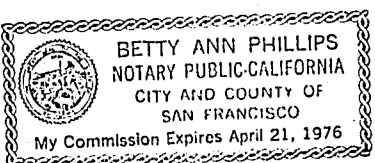
