## REFEREE'S DEED ON PARTITION

THIS IMDENTURE, made this 28th day of February, 1973, between BRYANT WILLIAMS, Peferee, party of the first part, and LLOYD C. MICHOLSON, party of the second part,

## WITNESSETH:

That WHEREAS, in an action of partition in the Circuit Court for the County of Klamath, State of Oregon, No. 68-142 E., wherein LLOYD G. NICHOLSON and DOROTHY WAE NICHOLSON were Plaintiffs, and JOYCE WILLER AVILLA, et al, were Defendants, the party of the first part was, on the 10th day of October, 1972, after a finding by said Court upon receipt of satisfactory proofs that said property could not be equitably divided into the requisite number of shares, duly appointed as Referee, and directed to sell the following described real estate, situated in the County of Klamath, State of Oregon, and more particularly described as follows, to-wit:
