by and between the STATE OF OREGON, by and through its STATE HIGHWAY COMMISSION, hereinafter called "State" and JAMES E. and WILDA L. CHANEY, hereinafter called "Owners";

WHEREAS, State by deed recorded July 5, 1972, in Book M72, at Page 7243, Deed Records of Klamath County, Oregon acquired certain property situated in the NE4SW4 of Section 1, Township 39 South, Range 9 East, W.M., Klamath Couunty, which deed in part, reserved unto Owners access rights to and from the Southwesterly side of the relocated Klamath Falls -Lakeview Highway opposite Engineer's Station 153+95 in a width of 50 feet; and

WHEREAS, by mutual agreement between the parties hereto two access approaches on the Southwesterly side of said highway were constructed opposite Engineer's Stations 153+86 and 154+31 instead of opposite said Station 153+95; and

WHEREAS, it is now desired by the parties hereto to show in the public records the correct location of the accesses as constructed and allowed by State.

NOW, THEREFORE, THIS INDENTURE WITNESSETH that for and in consideration of the grant hereinafter made by State, OWNERS do hereby transfer and relinquish unto State, its successors and assigns, their access rights to and from the Southwesterly side of the relocated Klamath Falls - Lakeview Highway opposite said Station 153+95 reserved in the above mentioned deed; and STATE, in consideration of the relinquishment herein made by Owners, does hereby grant and convey unto Owners, their heirs and assigns, access rights to and from the Southwesterly side of said highway opposite said Stations 153+86 and 154+31 in widths of 35 feet and unrestricted as to use.

Except as modified herein, said deed recorded July 5, 1972, shall remain in full force and effect and the rights of access herein granted shall be subject to all the provisions of said deed, including the frontage road and suspension provisions thereof, as fully as if set forth herein.
