Notice is hereby given that N. E. McCutcheon claims a lien upon logs felled and bucked in connection with the homestead sale in the Prospect Ranger District, the majority of which logs have been marked with red spray paint dots on the ends thereof, in a quantity of approximately 3.5 million board feet and which logs are now lying in Sections 33 and 34, T. 32S, R. 4E,; Sections 1, 2, 3 and 12, T. 33S, R. 4E,, W.M. Surveyed, Jackson County, Oregon and Sections 6 and 7, T. 33S., R. 5E., WM. Unsurveyed, Klamath County, Oregon, for labor and assistance rendered by claimant in felling and bucking said logs under an agreement with defendant which provided that claimant would receive from defendant the sum of \$1.875 per 1,000 board feet gross truck scale felled and bucked. That the name of the owner of said timber is Boise Cascade Corporation and that the agent for the said owner is Kenneth Shaw, dba Norelco Logging, contract logger for Boise Cascade Corporation; that Kenneth Shaw, dba Norelco Logging, as agent for Boise Cascade Corporation, employed N. E. McCutcheon, the above named claimant, to perform such labor and render such assistance in felling and bucking said timber; that the contract has been fully performed and fully complied with on the part of N. E. McCutcheon, the claimant, who performed labor upon said timber by felling and bucking same for a period of five months and approximately 25 days. That said labor and assistance were so performed and rendered upon the property between the 16th day of September, 1972, and the 6th day of March, 1973, and the rendition of such services was closed on the 6th day of March, 1973, and 30 days have not elapsed since that time; that

the amount of claimant's demand for the services is the sum of \$6,562.50; that no part thereof has been paid except the sum of \$3,929.01, and there is now due and remaining unpaid thereon, after deducting all just credits and off-sets, the sum of \$2,633.49, in which amount claimant claims a lien upon such property.

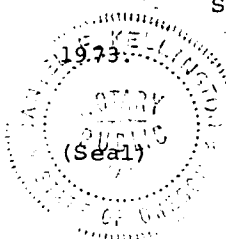
