BARGAIN AND SALE DEED

KNOW ALL MEN BY THESE PRESENTS: That we, Frank Miles and Letha Miles, husband and wife, for and in consideration of the sum of Ten Dollars and other valuable consideration, have bargained and sold and by these presents do bargain, sell and convey unto him, Frankie Garrett, of Lakeview, Oregon, all of our right, title, estate and interest in and to the following described real property situated within Klamath County, State of Oregon to wit:

PARCEL 1:

A portion of Lot 1, Section 31, Township 29 South, Range 7 E.W.M., more particularly described as follows:

Beginning at the corner common to Section 36, Township 29 South of Range 7 West, Section 31, Township 29 South of Range 7 East and Section East, Section 1, Township 29 South of Range 7 East, Willamette Meridian and 5, Township 29 South of Range 8 West, Willamette Meridian and running thence North along the line between said Sections 36 and 31, 315 feet more or less, to a point which shall coincide with the south line of a tract in the SW 1/4 of SW 1/4 of said Section 36, presently owned by Frank Miles and Letha Miles, the true point of beginning; thence East 60 feet; thence North parallel to the Township line 240 feet; thence South along the Township line 240 feet; thence West 60 feet; thence South along the Township line 240 feet to the point of beginning.

A portion of the Southeast Quarter of the Southeast Quarter of Section 36, Township 29 South, Range 7 E.W.M., more particularly described as follows:

Beginning at a point which is 314.5 feet North of the South-east corner of Section 36, Township 29 South, Range 7; thence East at right angles to said East Section line 70 feet; thence North parallel to the East line of said section 345.5 feet, more or less, to the South line of that parcel of property described in Volume 120 at page 451, Deed Records of Klamath County, Oregon; thence East along the South line of said property 60 feet to the said section line; thence South 345.5 feet more or less, to the point of beginning.
